



1           **WHEREAS**, as a direct result of the Town's fiscal inability to provide additional  
2 public safety personnel to help protect this use and the general public, and the Town's  
3 inability to control the locations for this use, the Town believes that it is in the best interest  
4 of the health, safety, and welfare of its residents to maintain its complete ban on  
5 cannabis-related uses.

6           **NOW THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE**  
7 **TOWN OF SOUTHWEST RANCHES, FLORIDA:**

8           **Section 1:** The foregoing "WHEREAS" clauses are hereby ratified and confirmed  
9 as being true and correct, and are hereby incorporated herein and made a part hereof.

10           **Section 2:** The Town hereby ratifies Ordinance No. 2017-03, and it  
11 maintains its complete ban on cannabis-related uses.

12           **Section 3: Conflicts.** All Ordinances or parts of Ordinances, Resolutions or  
13 parts of Resolutions in conflict herewith, be and the same are hereby repealed to the  
14 extent of such conflict.

15           **Section 4: Severability.** If any word, phrase, clause, sentence or section of  
16 this Ordinance is, for any reason, held unconstitutional or invalid, the invalidity thereof  
17 shall not affect the validity of any remaining portions of this Ordinance.

18           **Section 5: Effective Date.** This Ordinance shall take effect immediately upon  
19 passage and adoption.
