

**RESOLUTION NO. 2002-38**

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF SOUTHWEST RANCHES, FLORIDA, APPROVING AND REQUESTING IMPLEMENTATION OF A LIST OF CHANGES FOR THE GRIFFIN ROAD WIDENING PROJECT FROM SW 160 AVENUE TO SW 186 AVENUE; AUTHORIZING THE MAYOR, TOWN ADMINISTRATOR AND TOWN ATTORNEY TO DISTRIBUTE AS APPROPRIATE; PROVIDING AN EFFECTIVE DATE THEREFOR.**

**WHEREAS**, the Town Council approved Resolution #2002-3 on October 11, 2001, which transferred all trafficways within the boundaries of the Town to the Town, excluding Griffin Road; and

**WHEREAS**, Griffin Road, from SW 160 Avenue to SW 186 Avenue, is a trafficway located within the boundaries of the Town and is classified as a County Road; and

**WHEREAS**, Broward County is responsible for the current widening project on Griffin Road; and

**WHEREAS**, it is of mutual benefit to the residents of County and Town to complete the widening project with meaningful input from the Town; and

**WHEREAS**, Broward County has expressed a desire to consider changes to the current plans on Griffin Road, from SW 160 Avenue to SW 186 Avenue; and

**WHEREAS**, the Town has conducted three (3) public input workshops on the Griffin Road Widening Project, and;

**WHEREAS**, the Town Council has reviewed the list of improvements from the three (3) public input workshops at the April 11, 2002, Town Council meeting; and

**WHEREAS**, the Town Council wants to have the changes implemented by the County and all other appropriate agencies and companies as soon as possible.

**NOW, THEREFORE, BE IT RESOLVED**, by the Town Council of the Town of Southwest Ranches, Florida:


**Section 1:** The above referenced recitals are true and correct and are incorporated herein by reference.

**Section 2: Authorization.** The Mayor, Town Administrator and Town Attorney are hereby authorized and directed to pursue the implementation of the requested changes (attached) as follows:


- a) Distribute Resolution and list of requested changes to County and all other appropriate agencies and companies.
- b) Obtain necessary technical and engineering input to support the list of requested changes.
- c) Establish necessary meeting with County and affected agencies, companies and individuals to implement requested changes.
- d) Prepare biweekly updates for Town Council which will provide a status of the various requested changes.

**Section 3:** That this Resolution shall become effective immediately upon its adoption.
