

**RESOLUTION NO. 2002-79**

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF SOUTHWEST RANCHES, FLORIDA APPROVING A CONTRACT WITH SIGA, INC. FOR LANDSCAPING AND IRRIGATION AT THE SUNSHINE RANCHES EQUESTRIAN PARK; AUTHORIZING THE MAYOR, TOWN ADMINISTRATOR AND TOWN ATTORNEY TO ENTER INTO A CONTRACT FOR \$628,743.34; PROVIDING AN EFFECTIVE DATE**

**WHEREAS**, the Town has provided funding for the landscaping and irrigation at the Sunshine Ranches Equestrian Park; and

**WHEREAS**, the landscaping and irrigation is essential to continue development of the Sunshine Ranches Equestrian Park; and

**WHEREAS**, on September 3, 2002, the Town Administrator received Bids for the construction of facilities and infrastructure at the Sunshine Ranches Equestrian Park from five (5) firms; and

**WHEREAS**, the Town Administrator has analyzed the proposals, discussed the proposals and recommends that a contract be prepared.

**NOW, THEREFORE, BE IT RESOLVED** by the Town Council of the Town of Southwest Ranches, Florida:

**Section 1:** The above referenced recitals are true and correct and are incorporated herein by reference.


**Section 2:** The Town Council hereby authorizes the contract between the Town of Southwest Ranches and PHI Construction, Inc., Inc. for the landscaping and irrigation at the Sunshine Ranches Equestrian Park, for a total cost of \$628,743.34.

**Section 3:** The attached contract shall be executed by the Mayor, Town Administrator and Town Attorney, subject to contract adjustment that may be necessary in order to produce the intent of the Town Council.



**Section 5:** That this Resolution shall become effective immediately upon its adoption.


