Leah McDonnell motioned to excuse the absences. Priscilla Prado-Stroze seconded the motion and it passed unanimously.

Discussion Items:

- Debbie reported that \$25,681 has been collected and \$1,200 to be collected to date.
- Debbie read the budget expenses: \$1,338 we've used of budget (renews Oct 1<sup>st</sup>)
- \$15,837 collected for Mr. & Miss SWR Pageant vs. \$16, 662 in Minutes, \$825 difference
- \$6,700 was raised at the Barn Dance, \$3,800 was collected in tickets, \$2,900 was collected at Silent Auction
- Next fundraising event – Sikh Society 5KRun/Walk on Sat. March 30<sup>th</sup>.
- New Ideas for future fundraisers: making the Barn Dance more family friendly by having it during the day instead of at night.

New Business:

- Start a binder for each event with what to do for each event
- May 7<sup>th</sup> is the deadline for scholarship applications
- At the June 13<sup>th</sup> Town Council Meeting at 7 p.m. Scholarship recipients will receive their award certificates.
- Next SEAB meeting is scheduled for April 8<sup>th</sup> and we will discuss the calendar for next year's fundraisers.
